The Central District is pleased to bring you the latest information concerning utility rates, project developments, Public Service

Commission actions and other news you can use. I hope you will find this information to be a useful resource to learn about the Public Service Commission, consumer issues and the continuous work we are doing for the citizens in the Central District and across the state of Mississippi. ## Taking a Lap Around Lauderdale County

Meridian and Lauderdale County, like many places in Mississippi, has a rich history in music, manufacturing, military and much more. However, I recently spent time in Lauderdale County to recognize energy efficiency investments, tour utility-scale renewables and observe utility relocation efforts.

I joined Atmos Energy to make a \$14,600 rebate check
presentation to the Lauderdale
County School District for the
purchase of energy-efficient
equipment at Clarkdale
Attendance Center, Northeast
Middle School and Northeast High
School. The systems eligible for
the rebate and include 18 furnaces
with 96% AFUE, over 300
programmable thermostats, and 5
energy efficient condensing water
heaters in cafeterias. In addition



to the rebate, the estimated annual utility bill savings from the installation of these systems is over \$7,000. By being more energy efficient, the savings from improved energy performance can help pay for school supplies, building improvements and other upgrades that enhances each school's learning environment. Under the direction of the MPSC, Atmos Energy has implemented energy efficiency programs for customers through its Energy SmartChoice program.



Providing clean power for nearly a year now, the Meridian III Solar Project boasts nearly 570,000 solar panels located on approximately 650 acres. Developed, owned and operated by Silicon Ranch Solar, the 75 MW (DC) solar farm has a system that allow the panels to track the sun's movement through the day to maximize energy output. Mississippi Power Co. purchases the electricity produced by the solar farm located near the Toomsuba community. Not only does the solar farm provide cost-effective, clean energy to homes and

businesses in east Mississippi, but the solar farm serves as a long-term revenue source for Lauderdale County Schools since approximately two-thirds of the solar farm is located on Sixteenth Section lands.

I wrapped up the day visiting downtown Meridian to check out progress with the 5th Street Revitalization Project Area. The project included streetscaping measures like new sidewalks, vegetation, and lighting. Key to the project is the undergrounding of previously overhead utilities. Now with the electric and telecommunications systems placed in underground conduits, the aging wooden poles can be removed to give the area a less cluttered skyline and open up the sidewalks for better pedestrian flow. Meridian leaders are working hard to enhance the downtown area in order to bring people and businesses back.

## Last week at the MPSC

☐ Matrix Telecom LLC d/b/a Lingo filed a <u>tariff revision</u> that changes the name of Impact services to Lingo and revises bundled service rates.

☐ Waste Water Solutions LLC submitted <u>revised maps</u> of certificated areas in Lauderdale and Rankin Counties that it intends to assume control and operation.

The Town of Belmont in Itawamba County received <u>Commission approval</u> to provide natural gas services to areas 5 miles or more beyond its city limits.

The MPUS, MS River Gas LLC and C&M Gas Holdings have entered into a <u>Joint Stipulation</u> setting conditions for the transfer of the controlling interest in MS River Gas LLC to C&M Gas Holdings. MS River Gas LLC leases and operates three municipal natural gas systems in the

Central District: Fayette, Port Gibson and Tchula.
