Celebrate National Safe Digging Day with the MPSC and the Mississippi 811 Team

n underground utility line is damaged every six minutes in the United States, meaning that ten times an hour, a potentially dangerous and quite costly incident causes a utility outage for anywhere from one customer to an entire neighborhood, business park or factory.

National Safe Digging Day is Aug. 11 (also known as 811 Day) and serves as an important reminder that everyone, whether a homeowner with a shovel or a professional excavator with an earthmover, must "Call Before You Dig." It is not just a slogan, it is the law. Contact the Mississippi 811 One-Call <u>Center</u> at least two working days in advance of a digging project. Then wait the required time for utilities to respond to your request before putting a shovel in the ground.

Since January 2021, Mississippi 811 agents have received 281,043 calls (a 14.15% increase over 2020) and processed 291,165 tickets, including virtual locate requests which resulted in nearly 1,367,944 utility locates being disbursed to the respective Mississippi 811 Member Utility Companies. Mississippi 811 currently has 1,053 utility members.

Don't make a judgment call, make a phone call. Know what's below. Every time you plan to dig, dial 8-1-1 (when calling within the state of Mississippi) or 800-227-6477 at least two working days before you plan to begin any excavation activity. You can also send an email to Tickets@ms811.org. It's free, it's easy, and it's the law. In 2019, an estimated 532.000 excavation-related damages to underground facilities occurred in the U.S. costing approximately \$30 billion in damage and losses. Also, underground utility damage can cost lives due to electrocution, explosion and other. Don't be a statistic. Make the call!

Infrastructure Investment and Jobs Act of 2021

The U.S. Senate passed the \$1.2 trillion <u>Infrastructure Investment and Jobs Act of 2021</u> by a vote of 69 to 30 on Tuesday morning. Among the many measures included in the bill: funding major expansion of high-speed internet (\$65 B); spending for roads, bridges, and public transit (\$149 B); investing in railroads (\$66 B), ports and airports (\$42 B); and funding for clean drinking water (\$55 B). It includes new measures to combat climate change, like money for electric vehicles and charging networks (\$14 B) and modernizing the power grid (\$28 B). The measure now goes to the U.S. House for consideration.

IPCC Releases Latest Report on Climate Change

Intergovernmental Panel on Climate Change (IPCC) has released the first part of the Sixth Assessment Report, <u>Climate Change 2021: The Physical Science Basis</u>. The report's core writing team says the report is the most up-to-date physical understanding of the climate system and climate change, bringing together the latest advances in climate science, and combining multiple lines of evidence from paleoclimate, observations, process understanding, and global and regional climate simulations. The 3,000-plus-page report claims warming is already accelerating sea level rise and worsening extremes such as heat waves, droughts, floods and storms. Tropical cyclones are getting stronger and wetter, while Arctic sea ice is dwindling in the summer and permafrost is thawing. All of these trends will get worse, the report said. The report also claims that nearly all of the warming that has happened on Earth can be associated with emissions of heat-trapping gases such as carbon dioxide and methane.

EIA Expects 7% Increase in U.S. Energy-Sector Carbon Dioxide Emissions in 2021

Increased economic activity and a changing fuel mix in the electric power sector in 2021 will lead to a significant increase in energy-related carbon dioxide emissions this year, according to the U.S. Energy Information Administration's (EIA) August <u>Short-Term Energy Outlook</u> (STEO). After decreasing by 11% in 2020, U.S. energy-related CO2 emissions will increase by 7% to reach 4.9 billion metric tons this year. However, CO2 is not expected to reach pre-pandemic levels.



NOAA Expects 2021 Hurricane Season to be More Active than Previously Forecast

The <u>2021 Atlantic hurricane season</u> is likely to be busier than National Oceanic and Atmospheric Administration (NOAA) meteorologists previously predicted. In an update to its seasonal outlook, NOAA increased the number of hurricanes and named storms expected in another "above-normal" year. NOAA predicts 15 to 21 named storms, seven to 10 hurricanes, and three to five major hurricanes.

U.S. Solar Market Exceeds 100 Gigawatts

The U.S. solar market surpassed 100 gigawatts (GWdc) of installed electric generating capacity, doubling the size of the industry over the last 3.5 years, according to the <u>U.S. Solar Market Insight</u> <u>Q2 2021 report</u>, released by the Solar Energy Industries Association (SEIA) and Wood Mackenzie. Other <u>solar facts</u> include: 102.8 GW of solar installed in U.S.; 2,934,377 solar installations in U.S.; 231,474 people employed in the solar industry; currently enough solar energy installed to power 18.6 million households.
