

<u>Nuclear Science Week</u> is also recognized during the week of October 18-22. Nuclear Science Week is a week-long celebration focusing on all aspects of nuclear science and how nuclear science plays a vital role in the lives of Americans – and the world. Today, across the United States, <u>93 nuclear reactors at 55 power plant sites across 28 states</u>

power tens of millions of homes and anchor local communities. Nearly 100,00 people are employed in the nuclear power sector. 20% of the nation's electricity is generated by nuclear power.

Nuclear Science Week provides the opportunity to highlight advanced nuclear technologies that hold promise for less expensive, more efficient and even safer ways of generating electricity from nuclear. These innovative, evolutionary applications of nuclear energy elements can be categorized in terms of electrical generation capacity or by type of medium transferring heat from the fission reaction to the steam plant. Small modular reactors (SMRs), sized from 10 MW up to 300 MW, are scalable, can be built in less time with less upfront capitol. Advanced, next-generation reactors can reuse nuclear fuel, utilize a variety of heat transfer materials such as molten salt, high temp gas and liquid metal, and produce hydrogen to help industry achieve decarbonization goals.




Finally, October 20 is the <u>Ninth Annual</u> <u>National Bioenergy Day</u>. Bioenergy is often produced on a local or regional scale, creating benefits for rural communities. Here in Mississippi, bioenergy can be found in the production of wood pellets, cogeneration from biomass, thermal heat from wood chips,

biofuels from agricultural products and biogas from landfills and lagoons. Our office produced a <u>short video</u> capturing the key issues surrounding National Bioenergy Day and highlighting the impacts on Mississippi. Check it out!

# **Highlights of the October 14 Docket Meeting**

*The Mississippi Public Service Commission met on October 14, 2021, to consider the following <u>agenda</u> items:* 

- ☑ The Commission granted an Order Approving and Adopting the Stipulation between Atmos Energy Corporation and the MPUS concerning the Stable/Rate Annual Evaluation for the 12 Months Ending March 31, 2021. The Stipulation results in a decreased revenue requirement of \$5.6 million for Atmos which will reduce a residential customer's monthly bill by \$1.43. The Commission also considered and approved the Order adopting Atmos Energy Corporation's and MPUS's Stipulation in regards of Atmos's comprehensive review of its Capital budget for 2022 as required by the System Integrity Rider (SIR) Tariff. The SIR is the annual proposed spending to improve and replace main, distribution and service gas lines. The 2022 SIR revenue increase is \$8.35 million resulting in an increase of \$2.17 on a typical residential monthly bill. When combined with the rate impact of the Stable/Rate Annual Adjustment, the overall rate impact is a net increase of \$0.74 per month for the average residential customer.
- ☑ The Commission also granted an Order Approving CenterPoint Energy Resources Corp.'s Notice Filing of its re-determined Energy Efficiency Cost Rate (EECR). The rate adjustment will result in a reduction of \$0.05 for the average residential customer.
- ☑ The **Commission** considered and approved an <u>Order</u> for **Entergy Mississippi, LLC**'s Application for Approval of an Agreement to Provide Resiliency Service to the U.S. Army Corps of Engineers in **Warren County.** The Resiliency Services system includes eight 400 kW natural gas-powered engines capable of providing 3.2 MW of backup power to the USACE Secure Computing Facility. The USACE will pay an Additional Facilities Charge sufficient to cover the 20-year useful life of the backup generators.
- The Commission entered an Order approving Entergy Mississippi, LLC's Notice of a Routine Change in the Standard Rate for Purchases of Electric Energy and Qualifying Cogeneration and Small Power Production Facilities with Design Capacity of 100 Kilowatts or Less. The new rate schedule QF-20 increases the all-hours avoided energy price from 2.728 cents per kWh to 2.983 cents per kWh, an increase of 0.255 cents per kWh.
- ☑ The Commission approved an Order in connection with Mississippi Power Company's Petition for Accounting Order Related to Restoration Costs for Hurricanes Zeta and Ida. By moving hurricane restoration costs to a regulatory asset account, the property damage reserve account gets replenished with approximately \$39 million. Costs will continue to be subject to prudence review. Hurricane Zeta resulted in 94,000 outages and the replacement of over 1,600 spans of wire, 500 poles, 300 transformers and 18 transmission structures.
- ☑ The Commission considered and approved an <u>Order</u> Referring the Matter of Prime Developers Inc. and its Intent to Establish Rates for its Sewer Service in its Certificated Area in Lauderdale County to Commissioner Brent Bailey for hearing, report and recommendation.

- ☑ The Commission entered an Order Denying Rankin County's Motion to Intervene in Entergy Mississippi, LLC's annual financial and fuel procurement audit. The Commission found that the fuel audit statute does not contemplate intervention by third parties to maintain audit independence. However, Rankin County can participate should the Commission initiate proceedings per the findings of the audits.
- ☑ The Commission instructed the MPSC Legal Staff to draft an Order reflecting three parts: 1) instructing the Midcontinent Independent System Operator (MISO) to respond to certain questions posed by the Commission; 2) instruct Entergy Mississippi LLC to respond to certain questions posed by the Commission; 3) request reply comments from all parties who have intervened in 2021-AD-52.
- ☑ The Commission voted to recognize October as National Cooperative Month and draft resolutions recognizing the value of the state's 25 rural electric cooperatives.

- ☞ The Commission issued a <u>Suspension Order</u> in regards to Spire Mississippi Inc.'s Notice of its Filing of Routine Changes in its Rate Stabilization Adjustment Rider (RSA).
- The Commission issued a <u>Suspension Order</u> in regards to Entergy Mississippi, LLC's Notice of Intent to Change Rates by offering its Fast Charging for Electric Vehicles Rate Schedule.
- CenturyLink Communications, LLC in addition to Lumen Technologies, Inc., and Connect Holdings, LLC filed their <u>Joint Application</u> for Approval of Transfer of Control in order to complete the intra-company and reorganization transaction necessary.
- CenturyTel Broadband Services, LLC filed its <u>Application</u> for a Certificate of Convenience and Necessity to Provide Facilities-Based and Resold Competitive Local Exchange and Interexchange Services throughout the State.
- Entergy Mississippi, LLC filed Application for Approval of Amendment to Agreement for Service with Nissan North America, Inc. for the provision of electric service to Nissan's manufacturing facilities located at Canton within Entergy Mississippi, LLC certificated area in Madison County.
- ▷ Entergy Mississippi, LLC filed its October 2021 <u>Ouarterly Report</u> on the Construction and Operation Status of the 100 MW Sunflower Solar Facility.
- The Commission issued its Order approving CenterPoint Energy Resources Corp.'s Compliance Tariffs in regards to its routine changes in its Rate Regulation Adjustment Rider (RRA).
- The Commission also issued an Order approving CenterPoint Energy Resources Corp.'s Compliance Tariffs in regards to its routine changes in its Supplemental Growth Rider (SGR).
