Energy Related News and Notes

Congress Set to Act on FY2023 Omnibus Spending Bill

Congress worked through the weekend to finalize text for the \$1.7 trillion fiscal 2023 omnibus spending bill. The bill text was released Tuesday morning and Congress begin moving quickly to secure passage of the bill by the end of the week. The 177th Congress will also finish its work upon final adjournment. The 4,155-page <u>Consolidated Appropriations Act, 2023</u> covers annual spending for every federal agency and supplemental aid for Ukraine and natural disaster victims, as well as an extensive set of unrelated policies.

2023 Energy Efficiency Impact Report Released

The <u>2023 Energy Efficiency Impact Report</u> quantifies the powerful impact of energy efficiency across key sectors of the American economy and demonstrates how efficiency investments lower energy bills, improve public health and reduce emissions. The report was released by the Alliance to Save Energy, American Council for an Energy-Efficient Economy, and the Business Council for Sustainable Energy and quantifies recent progress on energy efficiency and points to critical opportunities ahead as consumers face increasing energy costs. The report outlines specific opportunities to further cost savings such as adopting stronger energy codes for new buildings and building performance standards for existing ones. Further adoption of industrial efficiency measures can continue to drive down costs for firms, and residential energy efficiency programs can increase the comfort and affordability of homes. Other notable findings from the report include:

- More than 60% of low-income households in the U.S. face a high energy burden, with some paying more than 20% of their income on utility bills
- Investments in energy efficiency have driven down energy consumption per household by approximately 16%
- Energy efficiency investments have reduced today's energy expenditures by approximately \$800 billion and federal funding for energy efficiency programs have increased by 61% in the last decade
- Utility investments in energy efficiency have grown, achieving 16% more electricity savings and 94% more gas savings in 2020 than in 2011

New Data Shows States With Highest and Lowest Number of EV Charging Stations

Mississippi ranks #45 in the nation for both the total number of electric vehicle (EV) chargers at 433 and number of EV charges per 100,000 residents at 14.6. The <u>data</u> is from DOE's Alternative Fuels Data Center. California has approximately one-third of all the nation's electric vehicle charging stations (41,225), the largest number by volume. However, when the size of the state is accounted for, Vermont leads with 139.7 EV chargers per 100,000 residents.

While most EV owners charge their vehicles at home, widespread availability of charging stations would allow people with EVs to travel greater distances more easily. However, more EV chargers will not be sufficient by themselves to increase adoption of electric vehicles and alleviate range anxiety. The number of EV chargers must be distributed evenly, and more direct current (DC) fast chargers (Level 3) must be added to the mix of chargers being installed. The Bipartisan Infrastructure Law enacted in 2021 aims to invest \$7.5 billion in a national network of electric vehicle charging stations, with a goal of building out 500,000 EV chargers by 2030.


The costs of preparing the bulk electric network for this new load is still being discussed. A new study suggests that EV charging needs along highways will require interconnection to high-capacity transmission lines. The Electric Highways Study can help utilities and policymakers make smarter decisions about electric grid interconnections and infrastructure, avoiding repeated upgrades.

EIA Expects Higher Wholesale Electricity Prices in the U.S. This Winter

The U.S. Energy Information Administration (EIA) expects higher wholesale electricity prices this winter in every region of the country. According to EIA's December <u>Short-Term Energy Outlook</u> (STEO), the increase in wholesale winter electricity prices ranges from 31% higher in the Southwest to more than 60% higher in the mid-Atlantic and Central regions. Although the EIA expects that U.S. electricity customers will pay more for electricity, retail electricity prices should not increase as much wholesale prices this winter. EIA forecasts the U.S. residential electricity price this winter will average




14.9 cents per kilowatt-hour, an 8% increase from last winter.

Increases in costs of fossil fuels, particularly natural gas, used to drive electricity generators is responsible for much of the increase in electricity costs. Fortunately, dry natural gas production in the U.S. in 2022 is expected to set an annual record. EIA forecasts production to grow slightly in 2023, averaging between 100 Bcf/d and 101 Bcf/d for the year, about 2% more than in 2022. The additional production should push natural gas prices downward at the Henry Hub benchmark to average \$5.62 per MMBtu in the first half of 2023, compared with an expected December 2022 month average of \$6.34/MMBtu.

U.S. Battery Storage Capacity to Grow Significantly

According to surveys, developers and power plant owners plan to significantly increase utility-scale battery storage capacity in the United States over the next three years, reaching 30.0 gigawatts (GW) by the end of 2025. As of October 2022, 7.8 GW of utility-scale battery storage was operating in the U.S. Battery storage adds stability to variable energy sources such as wind and solar. Batteries help solve the intermittency problem by storing extra energy produced by wind or solar



generators for later use. The large amount of existing and planned solar and wind capacity across the nation presents a growing need for battery storage. At present, the 409 MW Manatee Energy Storage in Florida is the largest operating battery storage project in the country. Over 150 MW of battery energy storage projects are planned for Mississippi.

NARUC Submits Letter in Opposition to Federal Transmission Siting Proposal

Last week, the National Association of Regulatory Utility Commissioners (NARUC) sent a <u>letter</u> to Senator Joe Manchin expressing strong opposition to his proposed amendment's broad overreach and infringement on existing state siting authority and cost allocation authority for electric transmission projects. The proposal would give the Federal Energy Regulatory Commission carte blanche jurisdiction over electric transmission siting without respect to local circumstances or needs. I sent copies of the letter to each of our U.S. Senators' offices expressing our support for NARUC's position. The Senate blocked the amendment from getting attached to the National Defense Authorization Act.
